2023-B PLAN FOR THE ALLOCATION AND DISTRIBUTION OF REGIONAL GREENHOUSE GAS INITIATIVE AUCTION PROCEEDS

#### 1.0 **Authority**

The 2023-B Plan for the Allocation and Distribution of Regional Greenhouse Gas Initiative Auction Proceeds (Plan) is authorized by Rhode Island General Laws (RIGL) §23-82-1 et seq.

#### 2.0 **Definitions**

For the purposes of this Plan, the terms defined in RIGL §23-82-1 et seq. shall be given the same meaning as provided in the statute and regulations.

#### 3.0 Auction Proceeds included in the 2023-B RGGI Allocation Plan

- 3.1 RGGI, Inc. conducted Auctions #61 and #62 on behalf of the State of Rhode Island in September and December 2023.
- 3.2 The auction resulted in the following Gross Auction Proceeds for the state:

Auction #61 - \$5,010,071.30

Auction #62 - \$6,681,596.16

Total \$11,691,667.46

## 4.0 Adoption of the Plan for the Allocation and Distribution of Regional Greenhouse Gas Initiative Auction Proceeds

- 4.1 The Rhode Island Regional Greenhouse Gas Initiative Act provides for the use of Auction Proceeds. RIGL §23-82-6 requires that the Auction Proceeds be used for the benefit of energy consumers through promotion of energy efficiency, renewables and direct rate relief.
- 4.2. The Rhode Island Office of Energy Resources (OER) is authorized to allocate the auction proceeds for the following purposes, in a proportion to be determined annually by OER in consultation with the Rhode Island Department of Environmental Management (DEM) and the Rhode Island Energy Efficiency and Resources Management Council (EERMC):
  - (1) Promotion of cost-effective energy efficiency and conservation in order to achieve the purposes of section 39-1-27.7;
  - (2) Promotion of cost-effective renewable non-carbon emitting energy technologies in Rhode Island as defined in RIGL §39-26-5 and to achieve the purposes of chapter 39-26 entitled "Renewable Energy Standard";
  - (3) Cost-effective direct rate relief for consumers;
  - (4) Direct rate relief for low-income consumers;
  - (5) Reasonable compensation to RGGI, Inc.; and
  - (6) Reasonable costs of the OER and the Department of Environmental Management (DEM) in administering this program.
  - (7) For fiscal year 2023 only, the office of energy resources shall transfer \$3,000,000 from unallocated auction proceeds to the executive climate change coordinating council restricted receipt 2 account to maintain funding for the existing electric vehicle and electric bicycle incentive programs and to support other projects; and

- (8) Provided however, effective for fiscal year 2024 and thereafter, sale of allowances yielding in excess of four million five hundred thousand dollars (\$4,500,000) per auction shall be transferred to the Rhode Island office of energy resources, on behalf of the executive climate change coordinating council, for climate change related initiatives. The executive climate change coordinating council shall have exclusive authority to direct the use of these funds pursuant to \$42-6.2-3.1. The office of energy resources may act on behalf of the executive climate change coordinating council to disburse these funds. Provided further, that any transfer of allowances in a single fiscal year, pursuant to this section shall not exceed one million five hundred thousand dollars (\$1,500,000).
- 4.3 OER concludes that the Plan is consistent with applicable statutes. Public notice of the proposed Plan was provided on December 14, 2023. A copy of the Notice is attached hereto. There was an in-person public comment hearing held at the Department of Administration in Conference Room A (2<sup>nd</sup> Floor) on January 10, 2024, from 3:00 to 4:00pm. The public was allowed additional time to submit written comments until January 25, 2024.
- 4.4 OER has responded to all substantive comments received on the Plan and are provided in the attached document entitled Response to Comments.
- 4.5 The Plan was adopted in accordance with RIGL §23-82--8 and Chapter 42-35, the Administrative Procedures Act.

#### 5.0 Allocation of Auction Proceeds

- 5.1 Compensation to RGGI, Inc.
- 5.1.1 RIGL §23-82-6(a)(5) authorizes the reasonable compensation of an entity to administer the auction on behalf of the State of Rhode Island. RGGI, Inc. is the entity that conducted the auctions listed in Section 3.1.
- 5.1.2 There was no compensation to RGGI Inc. in Auction # 61 nor Auction # 62.
- 5.2 Administrative expenses
- 5.2.1 RIGL §23-82-6(a)(6) authorizes the reasonable costs of OER and DEM in administering the RGGI program. The total reimbursement to both entities shall not in any year exceed \$300,000.00 or 10.0% of the proceeds, whichever is greater.
- 5.2.2 Ten percent (10.0%) of total auction proceeds from the auctions listed in Section 3.0 is \$1,169,166.75. Therefore, as specified in RIGL §23-82-6(a)(6), OER and DEM shall each be reimbursed a total of \$584,583.37.
- 5.3 Interest Accrued on RGGI Proceeds
- 5.3.1 There is no accrued interest allocated in this plan.

- 5.4 Transfer to Executive Climate Change Coordinating Council
- 5.4.1 RIGL §23-82-6(a)(8) authorizes sale of allowances yielding in excess of four million five hundred thousand dollars (\$4,500,000) per auction shall be transferred to the Rhode Island office of energy resources, on behalf of the executive climate change coordinating council, for climate change related initiatives. The executive climate change coordinating council shall have exclusive authority to direct the use of these funds pursuant to § 42-6.2-3.1. The office of energy resources may act on behalf of the executive climate change coordinating council to disburse these funds. Provided further, that any transfer of allowances in a single fiscal year, pursuant to this section shall not exceed one million five hundred thousand dollars (\$1,500,000).
- 5.4.2 State fiscal year 2024 includes auctions #61 #64. Auctions #63 and #64 will take place in calendar year 2024.
- 5.4.3 \$1,500,000.00 shall be transferred to the Rhode Island Office of Energy Resources, on behalf of the Executive Climate Change Coordinating Council.
- 5.5 Allocation of Net RGGI Proceeds
- 5.5.1 After accounting for administrative expense reimbursement to OER and DEM, compensation to RGGI, Inc., and accrued interest, the net balance available for programmatic allocation is \$9,022,500.71.
- 5.5.2 OER finds that allocating the balance of the Auction Proceeds for the promotion of cost-effective energy efficiency and conservation, promotion of cost-effective renewable non-carbon emitting energy technologies and direct rate relief to low-income customers shall be best accomplished by disbursements as follows:
- 5.5.2.a \$4,000,000.00 shall be allocated to be used for energy efficiency appliance and/or energy efficiency reduction measures in coordination with the federal Home Efficiency Rebate and/or Home Electrification and Appliance Rebate Programs that OER will be administering to help households reduce their long-term energy costs.
- 5.5.2.b **\$1,839,500.71** shall be allocated to support residential and commercial low- and moderate-income solar grant and financing programs by OER and Renewable Energy Fund
- 5.5.2.c \$683,000.00 shall be allocated to maintain ongoing support for the installation and operation of Air-Source Heat Pumps (ASHP) that Rhode Island Energy has been administering. ASHPs are critical measures for supporting the achievement of the state's greenhouse gas emission reduction goals. These funds will support direct customer incentives and/or customer financing programs delivered through Rhode Island Energy administered programs. Funds allocated to Rhode Island Energy shall be tracked and managed. Any funds not used by Rhode Island Energy for the ASHP program shall be transmitted back to OER no later than July 1, 2024, that will be repurposed for energy efficiency and/or renewable energy measures referenced in this allocation plan.

- 5.5.2.d **\$2,250,000.00** shall be allocated to support and implement energy efficiency and renewable energy projects at state agencies, municipalities, schools and/or private properties. Use of these funds may be done in collaboration with the Rhode Island Infrastructure Bank energy programmatic efforts to advance the goals of the State of Rhode Island's Lead by Example Initiative and Act on Climate objectives.
- 5.5.2.e **\$250,000.00** shall be allocated to support the Rhode Island Agricultural Energy Grant Program, a collaborative project of OER and DEM. This program helps local farmers "green" their operations and benefit from energy and cost savings achieved through energy efficiency and renewable energy projects. OER will coordinate with DEM on implementation of this program to support alignment with other existing clean energy initiatives available to Rhode Island's agricultural community.

### 6.0 Tracking and Reporting

6.1 Consistent with OER's reporting requirement under RIGL §23-82-6(d), all recipients of RGGI funding are required to comply with OER data and reporting requests, including, but not limited to, those reporting requirements specified in procurement documents and/or any memoranda of understanding.
